The protocol provides guidance for GHG emission reductions associated with the destruction of halocarbons sourced from Mexico and destroyed at facilities in Mexico. Errata and clarifications released for the Forest Protocol v5.0 and Mexico Forest Protocol v2.0


In early April, the Reserve released an erratum for the Forest Protocol v5.0 to provide guidance on the verification of soil carbon for avoided conversion projects and an errata and clarifications document for the Mexico Forest Protocol v2.0 to clarify the requirements for the standing live carbon pool for Agroforestry Activity Areas.
