us know what other improvements you would like to see in future releases.

We have a lot of activity happening now around Reserve protocol development. The Forest Project Protocol is being updated to increase its applicability and efficiency. The updated version, which we expect to have adopted in June, will cover forest offset projects across the U.S. and we're already excited to hear about several potential projects from throughout the nation. We also are continuing with the development of a co-digestion protocol and a coal mine methane protocol and have made significant progress in expanding the Landfill Project Protocol and Livestock Project Protocol to Mexico. In more exploratory work, we are investigating a potential protocol for industrial gases, and will hold a stakeholder meeting in Washington DC later this month.

Finally, I want to thank Robyn Camp for her many years of outstanding dedication and service to the California Climate Action Registry and the Climate Action Reserve. As the Vice President of Programs, Robyn oversaw and managed numerous services for our members. As of May 1, 2009, Robyn is serving full-time as The Climate Registry's Vice President of Programs. While she will be missed, we are excited that The Climate Registry and its Members will benefit from her expertise. We continue to encourage California Registry members to transition emissions reporting to The Climate Registry as any success in reporting and reducing emissions must be based on consistent data in an integrated system that stretches beyond California's borders. You will be carrying on your same pioneering work but on an international stage, and you will be working with many of the same people, like Robyn, who have been helping you with your emissions reporting at the California Registry.

Public Comment Deadline Extended for Forest Protocol Draft

The deadline for submitting public comments on the final draft version of the [updated Forest Project Protocol](#) has been extended. Comments must be submitted to policy@climateactionreserve.org by 5:00 PM PST on Monday, May 11.



The Forest Project Protocol is being updated to:

- Improve guidance for calculations
- Better address issues of leakage, permanence, and baseline estimation
- Incorporate harvested wood products carbon accounting
- Improve the efficiency and cost-effectiveness of methods

The final draft version of the updated Forest Project Protocol incorporates several changes to the December 2008 draft. During this second public comment period, the Reserve seeks feedback only on the changes made since the December 2008 draft. Tuesday, May 5: CARB GHG Reporting Webinar

The California Climate Action Registry, in conjunction with the California Air Resources Board (CARB), is presenting a special webinar to review the State of California's new mandatory greenhouse gas (GHG) reporting guidelines.

Members who are electricity retail providers or who have facilities large enough to be subject to the State of California's mandatory reporting regulation (25,000 metric tons CO₂ in 2008) are invited to join the webinar to review the state's mandatory reporting requirements and how they differ from reporting to the California Registry. Under the regulation, the first reports are due to CARB June 1, 2009, and CARB has developed a Reporting Tool for this purpose. Join us in Washington DC for the Industrial Gas and Ozone Depleting Substances Project Protocol Scoping Meeting

The Climate Action Reserve is exploring the prospect of one or more new project protocols related to the destruction or control of high global warming potential (GWP) industrial gases in the United States. To begin the protocol development process, we are hosting a public meeting to discuss possible industrial gas projects and solicit information and feedback from interested stakeholders.

The Climate Action Reserve is dedicated to the development of high quality, standardized protocols for greenhouse gas (GHG) reduction projects. Tentatively, we envision starting our industrial gas protocol development process with the development of protocols for projects that destroy or manage the release of refrigerants (HFCs) and ozone depleting substances (ODSs), and manage N₂O emissions at nitric acid plants. At the scoping meeting, we will explore issues around developing accounting methods and eligibility criteria for other possible industrial gas projects as well, including projects that address SF₆, HFCs, PFCs, NF₃ and additional N₂O emission sources. The new protocols will be used to register projects with the Climate Action Reserve.
